## Eligibility

To be eligible for nomination, the nominee must be:

- Employed in the Electricity Supply Industry in a transmission role; and
- Working toward, or recently completed, a national qualification at Level 3 or 4 under a Connexis Training Agreement. (People who completed their national qualification prior to 1 July 2022 are not eligible).

The nominee cannot be a previous winner of the Transmission Trainee of the Year Award.

## What makes a great nominee?

The Judges will be looking for an elevated level of excellence during the nominee's training, proof of a positive attitude, dedication to learning, and evidence the nominee is a role model to their peers.

The key to a strong nomination is providing the judges with clear, relevant information, and specific examples that give them a positive, factual picture of your nominee and their accomplishments.

The winner of the Transmission Trainee of the Year Award will receive a prize of \$1000.00 (this will be deposited into your nominated bank account after the event), a trophy and a certificate. They will also be considered for the Overall Trainee of the Year Award.

## Connexis Excellence Awards Dinner

Nominees selected as finalists will be required to attend the Connexis Excellence Awards dinner. Two dinner tickets will be provided - for the finalist and one guest. All costs associated with travelling to attend the Awards Dinner are to be met by the nominee or the organisation the nominee is employed by. Finalists are welcome to bring additional guests at their own expertise.

## The Process:

1. Nominations are made by completing the downloadable forms by 21 July 2023 [found here](#).
2. You will receive an email acknowledging receipt of the nomination.
3. Judges will review all entries and create a shortlist for each award.
4. Finalists will be announced on 4 August 2023.
5. Upon being named a finalist, both nominator and nominee will be contacted with information on next steps.
