

2025 CONNEXIS DOMESTIC PRICING SCHEDULE – WATER (PRICES APPLY FROM 1 JANUARY 2025)

Terms and Conditions – Pricing*

Domestic vs International Students – applies to all new enrolments in 2025

For a learner's enrolment to be eligible for funding from the Tertiary Education Commission (TEC), a learner must be either a Domestic Student or an Australian citizen / resident who currently resides in New Zealand. ("Domestic Student" means a New Zealand citizen or resident).

All other learners are considered to be International Students and, as such, their enrolment is not eligible for TEC funding – these learners will pay a different programme fee (please refer to the Pricing Schedules for International Students).

Exemptions: All enrolments in the following programmes are eligible for TEC funding where a learner is working in New Zealand on an Accredited Employer Work Visa;

- NZC in Infrastructure Works – Pipeline Construction and Maintenance Level 3 (PR-30300)
- NZA in Electrical Trade – Electricity Supply Strand Level 4 (PR-40579 & PR-40642)
- NZA in Infrastructure Works (Pipeline Construction and Maintenance) Level 4 – Stormwater and Wastewater strand (PR-40476 & PR-40634)
- NZA in Infrastructure Works (Pipeline Construction and Maintenance) Level 4 – Trenchless Technologies strand (PR-40475 & PR-40635)
- **Drinking-Water strand (PR-40633 & PR-40636) not on the Immigration NZ Green List of programmes*
- NZA in Infrastructure Works (Pipe Installation) Level 4 (PR-40620)
- MC in CCTV Inspection of Water Services Assets Level 4 (PR-40629)

We are applying to have more programmes added to this exemptions list – customers will be advised as these are confirmed.

Advanced Portfolio Assessment (APA) Pricing

Where Advanced Portfolio Assessment (APA) is available for a programme (denoted by * next to the programme name), the following rules apply;

- Where an employer has a registered APA assessor on staff, the On-Job with In-House Assessment price will apply
- Where an employer doesn't have a registered APA assessor on staff, the On-Job with External Assessment price will apply

Split Invoicing

For programmes with a duration of 15 months or more and where the enrolment fee is \$3000 or more, the payer may choose to split the payment over two years in equal instalments. The first instalment will be invoiced on enrolment and the second instalment will be invoiced at the 12-month anniversary. The applicable options have been shaded and highlighted in bold. All other prices will be invoiced in full on enrolment. In all cases the option for split payment does not apply to Advanced Portfolio assessment (APA).

Additional Service Fee

An Additional Service Fee of \$700 will apply to all enrolments that exceed duration and will be charged 2 months after the expected end date of the programme and on every anniversary thereafter until completion or withdrawal.

Document Format

Each programme will have one or more delivery options which affect the pricing. They are;

- On-Job Training with External Assessor – this is where the learner’s employer doesn’t have assessors on staff so an external assessor is contracted to assess the full programme for the learner
- On-Job Training with In-House Assessor – this is where a learner’s employer has assessors on staff who will assess the entire programme for the learner
- Off-Job (Provider) Training – this is where the learner attends off-job courses with a provider for the full programme.

NB where an external assessor will only be used to assess part of a programme, the On-Job with In-House Assessor price will apply and additional assessment fees will be charged at the external rate.
