As part of this course, you will be required to complete two unit standard assessments, provided by Connexis, as a learner prior to the course. These completed assessments will not be achieved on your Record of Achievement but are for the purpose of attaining unit standard 4098.

Please note that all new assessors must meet moderation requirements before being fully registered. This is a largely self-driven process, but it can take up to 3 months.

Cancellation

Cancellations or transfers to another course at late notice can impact the running of the course. We accept cancellations and transfers to courses scheduled no more than 10 working days in advance of the course without any charge.
